

Terms and Conditions

- 1. <u>Disclosure:</u> Anyone in a position to control the content of a continuing education activity must complete and submit the disclosure form located on the front of this document prior to the presentation, and ensure that the disclosure form is complete and truthful to the best of the presenter's knowledge.
